List of City /County Regulations

- 1) Set up is at 7:30 am on September 22nd, 2019. Please do not arrive earlier that this for set up since JCC Staff will not be available until that time for check in. We ask all vendors to complete set-up and be parked along the side streets of Mitchell Park by 9:30am. *The San Luis Obispo will be considerate of our event and not give out any tickets for our vendor cars.*
- 2) Clean-up is 4:00-6:30 pm. We ask all vendors to please wait until 4:00 pm to begin breaking down their booth. Please make sure your area is free from all garbage and small trash items.
- 3) No electricity is available at the event. If you need electricity, you must provide your own "whisper" type generator.
- 4) All Vendors will be assigned a location and each spot is numbered. A map will be sent before the show and also will be available at the Information Table upon check-in. If you joined us last year and want the same number that will be assigned to you.
- 5) All food vendors must comply with the SLO County Environmental Health Dept Restrictions. A SLO County Health Permit is required. Please contact the SLO County Health Dept for any questions. (805) 781-5514
- 6) All fees must be paid with your application. No fees will be accepted during the event. There will be no refunds due to unpleasant weather.
